WHEREAS, PL 1999 C440 amended the Local Public Contract Law and created a category of contracting called Competitive Contracting; and

WHEREAS, the Somerset County Park Commission pursuant to Resolution #R06-030 authorized the use of Competitive Contracting as required by 40A: 11-4.3(a); for golf shop resale merchandise; and

WHEREAS, the Purchasing Agent initiated the competitive contracting process for resale merchandise at the golf shops as per N.J.S.A. 40A: 11-4.1j Concessions; and

WHEREAS, the Director of Finance and Administrative Services and CFO of the Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part of hereof, and such funds are provided for in the budget of the Somerset County Park Commission: 33-260-56-470-201-660

WHEREAS, the Somerset County Park Commission Purchasing Office did on Wednesday, October 18, 2017 advertise in the Courier News, on the Park Commission website www.somesetcountyparks.org and on the Somerset County website www.co.somerset.nj.us; and

WHEREAS, November 9, 2017, (15) sealed proposals were received, opened, and read in public at 3:30pm prevailing time for Golf Shop Resale Merchandise, Contract # PC-COM-004-18; and

WHEREAS, the Park Commission desires to provide resale merchandise for the following Golf Courses: Green Knoll, Spooky Brook, Neshanic Valley, Quail Brook, and Warrenbrook; and

WHEREAS, the proposals were reviewed by the Evaluation Committee and have determined that the following proposals as submitted by:


